#### Statement of Purpose

IN JUNE 1967 jet aircraft and motor torpedo boats of the Defense Forces of the State of Israel brutally assaulted the American naval intelligence-gathering ship, USS *Liberty*, while in international waters off the coast of the Sinai Peninsula in the Mediterranean Sea. The attack was preceded by more than six hours of intense low-level surveillance by Israeli photo reconnaissance aircraft, which buzzed the ship as low as 200 feet directly overhead. The carefully orchestrated assault that followed was initiated by high performance jet aircraft. This was followed by slower and more maneuverable jets carrying na-



palm, and was finally turned over to lethal torpedo boats, which blasted a forty-foot hole in the ship's side. The attack lasted more than two hours, deliberately killing 34 Americans and wounding at least 171 others. Over 821 rocket, cannon and machine gun holes were inflicted. When the Liberty stubbornly remained afloat despite her damage, Israeli forces machine-gunned her life rafts, firefighters, stretcher bearers, and sent helicopters carrying troops to finish the job, no survivors were to be taken.

At this point, with Sixth Fleet rescue aircraft supposedly en route, the government of Israel apologized and the identity of the assailants became known.

Details of the attack were hushed up in both countries. Israel claimed that her forces mistook the Liberty for an Egyptian ship, and our government quietly accepted that excuse despite evidence to the contrary. No ship in our history has ever received such damage and casualties by accident. Then our government downplayed the intensity of the surveillance and the severity of the attack, and imposed a news blackout on the crew to keep the story under control. The official version is that the *Liberty* was reconnoitered only three times and only from a great distance. The American people were told that the air attack lasted only five minutes and that it was followed by a single torpedo and an immediate apology and offer of assistance. Nothing could be further from the truth. In June 1982, fifteen years after the assault, crewmembers reunited for the first time in Washington, D.C. It was a tearful, joyful reunion in which the men not only released their pent up emotions and decided that the **USS Liberty Veterans Association** would be formed with the firm goals of finding all crew members, holding reunions, proper recognition of Captain and crew (in particular those who lost their lives), obtaining a Congressional investigation into the attack, and...



## Remembering James Marvin Anderson Jr.

James Marvin Anderson Jr. age 74 died unexpectedly on Friday, November 12, 2021.

Funeral services were 2 pm on Wednesday, November 17 at Trinity Lutheran Church in Nicollet. Pastor Micah Plocher officiated and burial followed in Green Lawn cemetery in rural Nicollet.

James, known to many as Jim, Andy, Jimmy, Jim Bob and Papa was born in Bridgewater, SD on September 26, 1947 to James Sr. and Lydia (Golder) Anderson. He graduated from Menno High School in 1965. After high school he enlisted in the U.S. Navy and served until 1969. During this time, he served on the naval ship USS Liberty. On June 8, 1967 the ship was torpedoed in an unprovoked and deliberate attack. Jim was not injured and became part of the cleanup crew until the ship could make it back to dry dock. After his honorable discharge in October 1969, he worked construction which brought him to Nicollet. Jim was united in mar-



riage to Connie Gleason on May 22, 1971 at Trinity Lutheran Church in Nicollet. Over the next years he worked for Judson Market, Nicollet Ag and retired from Crystal Valley Coop where he continued seasonal work until his death.

Jim spent many years playing fast pitch softball where he made many lifelong friends. He was very passionate about his community and served on the Trinity Lutheran School board, was a member of the American Legion, Nicollet Conservation Club and served as Mayor and currently a city council member. Jim served on the Nicollet Fire Department for 30 years and continued to serve as Secretary Treasurer of the Rural Relief Fire Association Joint Powers Board. He also enjoyed spending many summers with friends and family at Rager's Acres Campground in Pequot Lakes, MN.

Jim was loved by everyone that met him. He had a smile for everyone and had the gift to gab. He was selfless and was willing to help out where ever he was needed. He would give the shirt off of his back to anyone who needed it. He never held a grudge and would encourage everyone to do the same. He was always level headed and kind. He loved his family deeply and his grandchildren were everything to him and he was everything to them! We will miss him dearly!

James is survived by his wife of 50 years, Connie (Gleason) of Nicollet. Daughter, Melissa (Rick) Theuninck of North Mankato, Josh (Quinci) Anderson of North Mankato, grandchildren Jordyn and Lindsey Theuninck and Weston Anderson. # The Events of the USS Liberty - As Told by Stephen Tracy

My family was not a typical military family: No one in my immediate family had served any serious time with the armed services for several generations. That would soon change in the 1960s.

I was the fourth child of five in a classic 50s-style life in Ithaca, New York, a college town in the Finger Lakes. My father and mother raised five kids on a meager income, public schools, lots of extra activities. We had an awesome summer cottage on Cayuga Lake and I spent summers swimming, fishing, water skiing and loafing (out of site from my father).

In the middle 60s, the Viet Nam build-up and the draft had my father very concerned, as four of his children were draft-eligible young men. He had not served in active duty in the armed services, but not from not trying. My father won an appointment to Annapolis in the 1920s to the great pride and admiration from his friends and family, particularly his mother. In his first semester at the Naval Academy, it was discovered that he was color-blind. In those days, that was a total disqualification. He was sent home. My grandmother cried for days.

My father, however, coped very well. He enrolled in prestigious Cornell University, earned his Bachelor's degree, and a Masters in mechanical engineering. He was an accomplished operatic baritone and became the director of the Cornell University Glee Club, had his own voice studio, directed the large Presbyterian Church Choir in Ithaca, and taught junior high school mathematics.

His grandfather (my great grandfather) was Benjamin Franklin Tracy, a farmer, land owner, lawyer, politician, and military man of great distinction.

My great grandfather was the quintessential American statesman and gentleman. He ran a 2,000-acre+farm in the southern tier of upstate New York, raising crops like wheat, tobacco and soy beans and raising standard bred horses. He was a loyal American and devoted to duty.

During the Civil War, he served directly under General Grant in the field and eventually became the Commandant of the Elmira prison camp, the "Andersonville of the North". He was decorated and recognized for his heroism and dedication to prison reform. He rose to the rank of General in the Army and received the Medal of Honor for his actions at the Battle of the Wilderness in May 1864.

He entered politics after the war and eventually became the Secretary of the Navy under President Benjamin Harrison, a cabinet position at the time. He was the President's closest advisor.

As Secretary of the Navy, he oversaw the creation of the first steel ships in the Navy, including the infamous USS Maine. He was later dubbed the "Father of the Modern American Fighting Navy."

His political ambitions were for real, as he considered a run for the White House. However, in 1889 his Washington house caught fire, destroying it and killing his beloved wife and daughter. His home was right down the street from the White House and the first person to his aid was none other than the President himself! Life was different then.

#### The Promotion of Chief Kukal

The making of a CHIEF.

As the majority of the crew knows, it is not an easy task to become a Chief Petty Officer in the United States Navy. In fact, if you want to become an "Honorary Chief" in the USN the Master Chief of the Navy has to approve your request. Our very own Petty Officer First Class Ronald Kukal had hoped to make the Navy a career and someday become a Chief, but Israel put an end to that back on June 8th 1967 when Ron's military career was cut short due to his medical injuries. Years and years of trying to get the justice he deserved by asking for an "Honorary Chief's" title came and went with no answers from Washington.

Then CDR Lewis and CWO3 Bowen filed the paperwork and tried their luck. As of this writing we have had no luck from Washington either. However, this 54th reunion gave the Liberty Veterans Association a chance to do something that our Washington lackies have failed to do. The crew decided to make Petty Officer Kukal "Honorary CHIEF Petty Officer" of the Liberty Veterans Association. As part of that "Honor" his first name now becomes Chief.

Chief Kukal will have his anchors officially pinned on his collar in November when Mr. Bowen and Mr. Tourney travel to Wyoming. When notified of his "promotion" Chief Kukal was speechless. When was the last time that has happened?

On November 14th Chief Kukal was "officially" presented with his collar devices making him the Honorary Chief of the Liberty Veterans Association. Mr, Mickey Lemay and Mr, Phil Tourney pinned the devices on his collar after Mr. Bowen administered the oath of office. The ceremony was held in the Liberty Fellowship church which was a packed house for this event. The entire congregation came up afterwards to congratulate the Chief and have us survivors sign copies of their REMEMBER The LIBERTY books. Pastor Baldwin did an excellent job of recapping the June 8th 1967 attack and the lack of government support both then and now.

#### Remembering David Edwin Lewis

COLEBROOK – David Edwin "Eddie" Lewis, 90, of Colebrook, passed away at his home on Saturday, Oct. 16, 2021, after a long period of declining health.


Ed was born in Colebrook on April 28, 1931, a son to the late Charles J. and Sophia R. (Slowick) Lewis, Sr. He was raised and educated in Colebrook, was a graduate of the Class of 1949 from Colebrook Academy, and later attended the U.S. Naval Academy, graduating in 1954. He later attended the post-graduate studies at the Naval College in Monterey, Calif., obtaining a degree in communications engineering.

Eddie's naval career spanned more than 25 years, and he retired in 1979 at the rank of Commander. His career took him all over the world, and he was wounded aboard the U.S.S. Liberty in the Mediterranean Sea when the nation of Israel attacked the ship, claiming a mistaken identification of the ship. For the rest of his life, Eddie bore the scars of that day, and he was deeply involved with the group of survivors, proving that the state of Israel and the Johnson administration deliberately staged the attack to try and draw the U.S. into the Israeli-Egyptian Six-Day War in 1967. In 2018, he was a central figure and collaborator in the book "Blood In the Water" which chronicles this dark episode of American military history.



Eddie also was a proud member of the Free & Accepted Masons and was a 50+-year member and Past Master of Evening Star Lodge #37 in Colebrook. He also held many other positions and memberships in many other appendant Masonic bodies, both locally and nationally. Eddie was also a life-long and faithful member of the Monadnock Congregational Church.

He leaves behind his wife, Dolores (LaCasse) Lewis of Colebrook; two sons, Michael C. Lewis and wife Paula of Chesapeake, Va., and Christopher J. Lewis and wife Wanda of Minneapolis, Minn.; a brother, Palmer Lewis and



# David Edwin Lewis - by Joan Mellen

#### David Edwin Lewis

He was a genuine, kindly man and a humble man, his humility so graceful that you might mistake it for simplicity. Dave himself would not set you straight. It was my great good fortune to number him among my closest friends so that we would, until his death, speak several times a week, and when I was completing "Blood in the Water," my book about the USS Liberty, every day. Occasionally I would repeat a question we had already covered. He pretended not to notice. He was ninety years old when the end came, but God blessed this good man: his intellect and his memory remained razor sharp.

He had long wanted someone to write the story of the USS Liberty for a particular personal reason: two Navy men of his acquaintance, having signed on for the mission, had asked Dave to allow them to retire. Dave urged them to serve this one last time. Both perished in the attack, a consequence that plagued him for the rest of his life. Someone telling the true story would assuage some of his guilt. But it had to be the truth.

I asked him, "why me?" I had never served in the US Navy, or in any military post. I didn't know the difference between an Admiral and a Commander. I had never been on a Navy vessel. I couldn't define what "all hands on deck" meant. I didn't know who among the survivors was to be trusted. He had never voted for a Democrat and I had never voted for a Republican.

None of our political differences mattered. Dave remained open and frank. He read my manuscript and soon discovered that that there was some confusion between John McCain, pere et fils. (Dave loved to throw some French into our conversations, a language he learned during his military service. One of his favorite sign offs was "don't let the bastards get you down!") The long-time CIA officer who read the manuscript, someone trusted by both of us, provided the necessary McCain corrections. But Dave himself also read it at least three times.



Later, Dave would tell people that he had taught me to "speak NAVY."

To our first meeting I had brought a copy of my book about the Kennedy assassination, "A Farewell to Justice," so that he might assess my ability as a researcher. There were unanswered questions about the killing of JFK as there were about who sponsored the murderous attack on the Liberty, who sent the ship up there to be massacred, for one. I found the answer in a summary of the attack published by the Joint Chiefs of Staff.

As the years passed, I discovered that Dave was a great patriot who loved his country, but that did not prevent him from doubting the official version of the Kennedy assassination, which had Kennedy being murdered by one Lee Harvey Oswald. During his Navy service, Dave had several run-ins with CIA, which he described to me. I told him about my own encounters with the Agency I while I was researching the Garrison case. It was among the areas we had in common. Dave suggested CIA was at least one cause of why he did not emerge from the Navy as an Admiral.

Only after years did I discover how beloved Dave was by his shipmates, as well as by the citizens of the whole town of Colebrook, New Hampshire where he was born. Many attended the party Dave and his wife Dolores organized for the book when it finally appeared. On that icy February afternoon Dave sat beside me at the local country club, as if to confer his approval. If he was tired, he never let that show. He had spent many hours at the bakery organizing the cake from a photograph of the Liberty at sea.

He purchased copies of the book because people began to treat him as the co-author. (He gave them all away – all you had to do was ask). In part my book is, indeed, a biography of Dave Lewis.

Dave forgave most people for their hesitancy in facing the truth, although many of his shipmates did not forgive him for revealing Lyndon Johnson's role – it amounted to nothing short of treason – in the saga of the Liberty. He had no problem with my conclusion about US government complicity in the attack. He was open-minded and a true liberal as revealed, if not by anything else, by his enthusiastic collaboration with me, a former anti-Vietnam war protester.

Almost from the start we began to tape our interviews: at the Masonic Lodge in Colebrook, wherever there was space, quiet and privacy. Three years after my book was published, we were still talking.


# Remembering Thomas William Lemond Jr.

Thomas William Lemond, Jr. November 23, 1944 - January 29, 2021

Columbia, South Carolina - Thomas William Lemond, Jr., 76, of Columbia, died Friday, January 29, 2021. Tom was born on November 23, 1944, in Columbia, S.C., to the late Mrs. Mildred Waites Lemond and Thomas William Lemond, Sr. He is survived by his wife of 40 years, Vivian (Vicky) Carol Lemond of Columbia, SC; son, W. Casey Lemond (Mallory) of Pinehurst, NC; brother, G. Franklin Lemond (Martha) of Johns Creek, GA; brother-in-law, R. Marion Brice of Ocean Springs MS, and grandson, William Bear Lemond.

Tom was a U.S. Navy veteran whose proudest moment was serving aboard the USS Liberty, a United States intelligence ship. On June 8, 1967, the ship was attacked during the Six-Day War between Israel and Egypt. The combined air and sea attack killed 34 crew members, wounded another 171 men, and severely damaged the ship. He was wounded during the attack and received a Purple Heart medal for his sacrifice.

As a proud Gamecock fan, Tom loved rooting for the football team during their ups and downs. He did not hesitate to beat you in Jeopardy unless a category about technology came up at which he would quickly concede to his son, Casey. Over the last year, his favorite activity was to video chat with his grandson, Bear, all the while gushing to everyone at the Veterans' Victory House about how perfect he was. Tom thoroughly enjoyed his extended family and will be missed by the many cousins, nieces, and nephews that loved him.

## A Crew Member's Request - From Nathan Benedict CTM2

Dear Mr. Graves,

I just finished reading an article I found in the September issue of the VFW magazine. The article reported on a study by the Army which showed a link between non-concussive blast effects and Alzheimer's disease. I was a crew member on the USS Liberty (CTM2) when it was attacked and nearly sunk in June of 1967. I was nearly killed by the blast of the torpedo. I did not suffer a concussion but I certainty was beat up by the blast. Later in life, I was diagnosed with Parkinson's disease. I am trying to establish the cause of my Parkinson's as being the result of the torpedo explosion.

I would like to ask that any USS Liberty crew member that has been diagnosed with Alzheimer's, Parkinson's or other neurological disease contact me or the LVA so I can tally up the results and see if there is a correlation between the torpedo blast and neurological damage sustained by the crew. In addition if you are receiving VA compensation for neurological problems I would like to know that as well.

## Remembering David William Hawkins

#### **DEER ISLE**

David William Hawkins died unexpectedly on July 27, 2021, at his home in Deer Isle, Maine, while working on a sailing dinghy for his granddaughter. David was born December 7, 1945, in Greenwich, Connecticut, to the Rev. John J. Hawkins and Jane Dudley Hawkins. He grew up in Riverside, Connecticut, and Harborside, Maine.

He arrived in Maine by schooner at six months of age. His love of Maine grew from summers spent with family messing around in boats and in his father's woodworking shop. He attended South Kent School (class of 1963) and later Columbia University. In 1964 he took time off from Columbia. He joined the Merchant Marine for the summer as crew aboard the cruise ship SS Argentina. He then joined the Navy, where he trained at the Defense Language Institute Foreign Language Center at the Presidio of Monterey, California. He was a member of the Blue Jacket Choir during initial training and sang for his supper.

In 1967 David was stationed in the Mediterranean Sea off the coast of North Africa as a Cryptologic Technician (CT3) on the USS Liberty, a lightly armed Navy technical research ship, during the onset of the Six-Day War. The Liberty was unexpectedly attacked and severely damaged by Israeli planes and torpedo boats, killing 34 and wounding 171 crew members, of which he was one. He was awarded the Purple Heart. In September 1968, David married Sarah "Sal" McCloskey in Maine. They returned to New York City and he graduated from Columbia University in 1971. They then moved to Boston, accompanied by a pet fox, skunk, and monkey. David graduated from the New England School of Law in 1974, where he was a member of the Law Review. For three summers, he clerked for William S. Greene, Esq. in Deer Isle, Maine. David took over the legal practice in 1974 when he moved permanently to Deer Isle. In 1975, he started work on a modern wooden house in an open field, building much of it himself. In 1980 and 1982, David and Sal had two children, Samantha J. Hawkins and Seth D. Hawkins. David was a founder of Shepard's Select Properties, Inc., a real estate brokerage in Deer Isle. From 1976 to 1986, David and his former wife, Sal, were partners in "Hawkins & McCloskey, Attorneys at Law" in Deer Isle. David married Emily Fuller Hawkins on May 27, 1989. They spent more than 30 years enjoying each other's company, whether on the water or touring in the MGB - V8. David was a quiet, shy, and patient gentleman of dry humor who perfected the art of life's simple pleasures. He sailed and raced a Leuters 16, "Claret," and in later years cruised Penobscot Bay, on the "Emily Anne." 


